Report of the National President

Financial Overview:

For the financial year 2023-2024, SUNGO has experienced a significant improvement in financial results compared to the previous financial year 2022-2023. The financial results for FY 2022-2023 resulted in a loss of \$194,741, whereas for FY 2023-2024, the results show a reduction of loss to \$127,696, representing an improvement of 34%.

Reasons for Improvement:

There has been an improvement in our financial stability due to securing multiple projects for the upcoming years. These projects cover most of our operational costs, including staff salaries.

Ongoing and New Projects:

Despite the financial challenges, SUNGO has been fortunate to secure multiple projects currently being implemented in this financial year. These projects include:

EU Project on Democracy: This project aims to enhance democratic processes and citizen participation.

RERIPA Microgrid Project: In collaboration with NUS and USP, this project focuses on renewable energy and sustainable power solutions for communities.

Good Governance Training Project: Funded by the Government of Samoa through the Ministry of Women, Community and Social Development under the District Development Project, this initiative aims to strengthen governance practices at district levels.

Volunteerism Workshops: Funded by the Australian High Commission, these workshops aim to promote volunteerism and prepare for CHOGM in October 2024, where SUNGO will co-chair the People's Forum.

Citizens Budget Guide: Funded by PIANGO, this project involves developing a tool to ensure CSOs' voices are included in the development of the National Budget.

Major Milestone:

A major milestone for SUNGO this financial year was earning the government's trust to co-chair the People's Forum at the Commonwealth Heads of Government Meeting (CHOGM) in October 2024. SUNGO's preparation for this significant event began in mid-2023, demonstrating our capability and commitment to fostering inclusive dialogue and engagement.

Report of the National Treasurer

The financial performance of SUNGO for the fiscal year 2023-2024 shows a significant improvement compared to the previous year, 2022-2023. This year, we recorded a net loss of \$127,696, representing a 34% improvement from the loss of \$194,741 in the previous year.

Income Analysis

The total income for the fiscal year 2023-2024 was \$150,532, a decrease from the \$403,947 recorded in the previous year. Key components of this year's income include:

Contract Management: \$49,261.07, down from \$68,372.82.

Hire and Project Recovery Costs: \$14,273.22, increased from \$4,338.00.

Membership and Subscriptions: \$4,800.00, increased from \$3,150.00.

New Project Incomes: Including UNDP Spotlight Initiative (\$5,720.76), Samoa Agreement Forum (\$1,296.90), PIANGO PFM Project (\$7,791.25), AVI Workshop (\$1,247.10), IOE Samoa EU Project (\$13,639.39), AVI Impact Fund (\$5,197.11), RERIPA Microgrid Project (\$3,770.00), MWCSD Good Governance Revenue (\$17,749.63).

Expenses Analysis

Total administrative expenses for the fiscal year 2023-2024 were \$208,065, a substantial reduction from the \$303,122 incurred in the previous year. Key expense reductions include:

Salaries SUNGO Administration: Reduced to \$57,331.73 from \$178,253.66.

Executive Council Meeting Expenses: Reduced to \$1,517.50 from \$4,956.40.

Electricity: Increased to \$4,215.43 from \$2,932.44.

Project expenses for the fiscal year 2023-2024 were \$70,162.34 down from \$295,566.09 in the previous year. This is due to major projects completed in the end December 2023.

Key reductions and new expenses include:

Staff Salaries - Project: Reduced to \$1,590.20 from \$84,286.04. The portion of staff salaries funded by projects have been attributed directly to Salaries Account in SUNGO's budget.

New Project Expenses: Including PIANGO PFM Project (\$7,791.25), MWCSD Good Governance Project (\$17,749.63), IOE Samoa EU Project (\$13,639.39), UNDP Spotlight Second Phase (\$5,720.76), and RERIPA Microgrid Project (\$3,770.00).

Net Loss

The net loss for the fiscal year 2023-2024 stands at \$127,696, a significant turnaround from the loss of \$194,741 in the previous year. This positive outcome is attributed to the completion of most projects in the previous year, effective cost management, and the strategic use of savings in the Reserve Account to maintain operations and support ongoing initiatives.



Conclusion

SUNGO has demonstrated resilience and adaptability in the face of financial challenges. The strategic reduction in administrative and project expenses, coupled with the initiation of new revenue-generating projects, has resulted in a much-improved financial position. Continued focus on effective project management and cost control will be crucial for sustaining this positive trend in the coming years.

Overview of the Year

SUNGO Annual Financial Overview for the Financial Year 2023-2024

The fiscal year 2023-2024 has been a period of financial recovery and strategic management for the Samoa Umbrella for Non-Governmental Organisations (SUNGO). This report provides an overview of our financial performance, highlighting significant improvements and key financial metrics from the Treasurer's report.

The fiscal year 2023-2024 has been a transformative period for SUNGO, marked by prudent financial management and strategic direction by management. The positive result demonstrates our resilience and ability to adapt to changing financial landscapes. Moving forward, SUNGO will continue to focus on sustainable growth, effective project management, and cost efficiency to ensure continued financial stability and support for our mission.

Strategic Objective One: Governance and Management GOVERNANCE STRUCTURE:

1. Introduction

The Samoa Umbrella for Non-Governmental Organizations (SUNGO) continues to play a vital role in enhancing civil society's impact in Samoa. The governance structure is pivotal to SUNGO's effectiveness, ensuring transparency, strategic planning, and robust policy development. This report provides an overview of SUNGO's governance structure, focusing on board meetings, transparency, strategic planning, and policy development during the financial year 2023-2024.

2. Board Meetings

Frequency and Attendance:

The SUNGO Board convened quarterly meetings, ensuring regular oversight and strategic direction. Special meetings were called as necessary to address urgent matters. Attendance remained high, with all board members demonstrating strong commitment to SUNGO's mission.

Communication:

SUNGO maintained open communication channels with its members and stakeholders. Regular updates on activities, project progress, and financial status were disseminated via newsletters, social media, and the official website.

1. Financial Management

SUNGO demonstrated strong financial management during the fiscal year 2023-2024. The organization's financial performance significantly improved, with the Treasurer's report indicating a positive balance of \$127,696, a substantial turnaround from the loss of \$194,741 in the previous fiscal year. Key aspects contributing to this improvement include:

Budgeting and Financial Oversight: The board's diligent review and approval of budgets and financial reports ensured that SUNGO's financial resources were effectively managed.

Project Funding: Successful acquisition of funding for several key projects, such as the EU project on democracy and volunteerism workshops funded by the Australian High Commission, bolstered financial stability.

2.1 Communication


There have been continuous improvements in the Samoa Umbrella for Non-Governmental Organizations' communications to and from its members, with regular newsletters, Media Releases and social media updates. Since SUNGO's Website reconstruction, its visibility has now been recognized and reached organizations outside of Samoa. The Website is updated more regularly with notices, press releases, newsletters, and information sharing with all member organizations and stakeholders.

SUNGO members organizations which are classified in to three different categories such as the Community Based Organizations, Charitable Trusts, and Non-Governmental Organizations, have been sent information for Meetings or Forums, Calls for Proposals, Newsletters, Media Releases, Notices of SUNGO Meetings or Forums, and recruitment throughout the year. This has generated more regular communication between the office and members. Media Releases detailing SUNGO events, as well as Job Vacancy Advertisements have also been sent out to media, have also increased SUNGO awareness and visibility. In addition to that, SUNGO organizations are also advised about their Annual Subscription Fees especially the outstanding fees. Member organizations are always encouraged to like and follow SUNGO's Facebook page, to ensure they are up to date with news, events and funding opportunities.


2.2 Facebook

Since SUNGO's Facebook Page was set up in March of 2015 with the aim to increase and upgrade its visibility and profile, more organizations both here and abroad have contacted SUNGO for assistance in accordance with its core roles and responsibilities. The Facebook page is updated regularly, sharing posts and happenings involving SUNGO. At SUNGO workshops, meetings, or Training activities, there is always a SUNGO information booth, so that participants that attend could have an idea of what SUNGO is, what it does, and how SUNGO works with its member organizations. Partnership with stakeholders and PIANGO promoting Pacific 2030, Vacancies and SDS's Strategies, are also posted on SUNGO's Facebook Page.

A number of member organizations have also linked successfully to this page and have shared a number of posts, advertisements and updates with their friends and connections on this social media platform. For this financial year, from 1st July 2023 to the 30th of June 2024, the total number of Facebook visits is 9.1 thousand, which is 73.2% of SUNGO Facebook fans.



The Facebook Reach mounted at 29.8 thousand.




There are more than two hundred The Facebook followers are 3,232 which is 68.5% women and 31.5% are men that are linked to the SUNGO Facebook page.





2.4 Monitoring and Evaluation and Learning

SUNGO wishes to continue with this important activity, because it is significant for strengthening the relations between SUNGO and its members as well as its stakeholders. The Annual Work Plan aims to achieve 75% of members visited at the end of each financial year.

2.5 Feedback from Members

Through the Meetings and Forums as well as Training activities conducted throughout this Financial Year, SUNGO members praised the umbrella for the continuous communication and information shared regularly.

Other comments made by members, are the need for fundings, and requested for Meeting Resources to always be printed out in the Samoan Language.

2.6 Information and Liaison

SUNGO communication with its members.

SUNGO's interaction and communications improved with its members in terms of reaching out to them with regards to Training Programs, Meetings or Forums, Consultations and more.

Increased number of members actively engaging with SUNGO.

There are also non-members of SUNGO who like and share SUNGO's Facebook posts to their friends and that expand the profiling and introduced SUNGO to new members. There were people that visited the SUNGO office and requested further information regarding SUNGO services for their community, based on receiving news from friends on SUNGO's Facebook page.

Existing members retained and new members recruited.

SUNGO increased its membership with six new members, raising membership from 228 to 234 members. The SUNGO membership database has always been updated and maintained by the ICO. The database divides into five thematic areas where we can easily allocate executive council members to meetings and forums. The list of these thematic areas is on the website for members and the communities to access. It is also attached to the report as *Appendix two*.

The public profile of SUNGO has been strengthened.

SUNGO utilizes communication about the role of civil society to its partners through Facebook, emails, press releases, quarterly newsletters and on its website.

2.7 Stakeholder Engagement

The Australian High Commission in Samoa updates SUNGO on the progress of the Tautua and Tautai Projects.

11th August 2023, SUNGO Office, Vaitele - The Samoa Umbrella for Non-Governmental Organizations CEO and the Australian volunteer Ms. Vanessa Morris met with the Deputy High Commissioner of Australia to Samoa, Ms. Claire McGeechan and her Team on Friday, 11th of August 2023, to follow up on the Tautai and Tautua Projects funded under the DFAT funding programmes. Building close partnership between DFAT and SUNGO was also discussed in the meeting.



SUNGO Executive Council Members met with the Honorable Prime Minister.

1st September 2023, Prime Minister's Office – SUNGO's Executive Council Members met with Honorable Prime Minister, discussing Good Governance Trainings that SUNGO will implement for 51 constituencies.

and CEO Fuimaono Vaitolo Ofoia.



SUNGO develops a partnership with International IDEA.

4th September 2023, SUNGO Office, Vaitele Tai - SUNGO met up with representatives from the Institute for Democracy and Electoral Assistance (IDEA), Mr Adhy Aman who is the Senior Programme Manager for Asia & the Pacific, and Mr Stephen Sherlock, who is a Visiting Fellow from the Australian National University.

SUNGO developed a partnership with IDEA through a joint proposal for EU Call for funding. SUNGO looks forward to working collaboratively with IDEA.

Common Challenges discussed by SUNGO and the UN

20 September 2023 - Capacity building and financing gaps are common challenges hindering effective NGO operations. On the 20th of September 2024, the RC Themba Kalua met and discussed with CEO of The Samoa Umbrella for Non-Governmental Organizations Inc - SUNGO Fuimaono Vaitolo Ofoia, opportunities to support and address these challenges. The RC was joined by the Resident Coordinator's Office Human Rights Adviser Momoko Nomura and staff members of the SUNGO Faapito Opetaia and Onosai Kitiona who were all engaged in an interesting conversation to understand the work of SUNGO in building a well-informed, resourced and strong NGO sector of over 250 members. The UN Samoa anticipates more dialogues and genuine collaborations with the NGOs, Government of Samoa and the UNIC Canberra

collaboration between stakeholders, with a shared commitment to building a brighter future for Samoa. With CHOGM on the horizon, there's a sense of excitement and anticipation as we work together to ensure that Civil Society in Samoa has a strong voice and meaningful representation on the global stage.

Strategic Objective Three: Institutional Strengthening

3.1 Capacity Building

Improved capacity of SUNGO member organisations and non-member civil society organisations to effectively manage their organisations and services to their communities.

SUNGO provides informal learning activities to its members and civil society organisations at the grassroots level where adult learning is encouraged. SUNGO endeavours to make knowledge and skills required by civil society organisations more accessible through informal training opportunities for our members. The main activity for SUNGO has been to provide institutional strengthening and training opportunities for its members as well as the civil society in Samoa.

Adequate pool of CAT qualified community trainers maintained.

Maintaining a pool of qualified and skilled community trainers is crucial to the delivery of a quality training programme. SUNGO coordinates a pool of registered community trainers. These trainers take responsibility for delivering need-based training for NGOs and communities/villages. SUNGO recruited ten (10) new community trainers early this year. There is a good gender balance and the newly recruited trainers also have a younger age profile which is important for both training balance and retention.

SUNGO have expressed the need to up-skill our members, preferably to meet the needs of individuals as well as the needs of communities.

SUNGO requested training for the continuous training and upskilling of community trainers in order to cope with demands for training in the different communities. The planning and delivery of Applied Training Skill short non-formal course is part of this process and a response to the need to equip and up-skill community trainers. There were fourteen (14) attended and completed the course (8 females and 6 males). None of the 14 passed the pre test but at the end of the training week all 12 participants sat the post test passed.

3.2 Training Needs Analysis

For this financial year, SUNGO did not conduct a training need analysis or training assessment due to funding as well as time constraint and completion of other projects. SUNGO will look into other possibilities to collect the training needs from our registered members for next year training programme. SUNGO is in progress of looking for funding to conduct its training programme as usual. SUNGO team will apply for funding when call for proposal is open.

3.3 Training Programmes Delivered

EU Spotlight Initiative:

SUNGO has taken the lead in organizing and implementing Capacity Building activities designed to empower women's movements and CSOs. SUNGO has been able to develop tailored training programs, workshops, and resources aimed at strengthening the skills and knowledge of women's movements and CSOs. These activities are geared towards promoting gender equality, fostering social inclusion, and preventing violence against women and girls.



This direct fund support to CSOs focuses on institutional strengthening support for SUNGO to enhance the core technical and functional capacities of CSOs who play a key role in implementing prevention and response initiatives, advocating with decision makers on positive change in laws and policies, as well as maintaining accountability of right holders on domestic violence issues.

The Capacity Building activities facilitated by SUNGO include:

- Leadership Workshops Empowering women leaders with effective leadership skills, strategic planning, and decision-making abilities.
- Advocacy Training Enhancing the advocacy skills of women's movements and CSOs to influence policies and promote gender equality.

The training conducted on 12 - 13 October 2023 at the TATTE Convention Centre attended by eighteen participants from nine (9) NGOs. There were fourteen (14) females and four males.

Pre The summary shows the increase average percentage of 67% which clearly states and increased in learning / improvement. All 18 participants sat the post test passed. The course evaluation was done

at the end of day 2 of the course. All 18 participants completed their evaluation and submitted it to the training team. 73% of the training participants were satisfied with the course overall.

SUNGO expresses its gratitude to the EU and UN Spotlight Initiative for their unwavering support and commitment to creating a safer and more equitable society for women and girls in Samoa. total of 7 Training courses were delivered in the last financial year and 5 training conducted and completed for this financial year ended 30 June 2023. SUNGO remains dedicated to working closely with its local partners, Government agencies, and communities to ensure the successful implementation of these Capacity Building activities.

Child Protection Policy – Australian Volunteer Program (DFAT) :

The Australian Volunteers Program provided funding for SUNGO to host and facilitate the one day child protection workshop as SUNGO is committed to the protection and safeguarding of all children. This one day training helps SUNGO members to formulate and/or revise their organisation's child protection policies according to National and Internation standards. The training held at SUNGO conference room on 15 March 2023.

The key objectives of this training are as follows;

- To establish clear guidelines and procedures for preventing and responding to child protection in organisations.
- To raise awareness among staff, volunteers and stakeholders about the importance of child protection and their roles and responsibilities in upholding these principles.
- To ensure compliance with National and International standards for Child Protection, including the Convention of the Rights of the Child and relevant legislation.



There were sixteen (16) participants attended the workshop, 13 females and 3 males. The one-day workshop conducted

by the Australian volunteer that helped SUNGO with this activity, Isckra Martines Carbajal and SUNGO programme team leader. In conclusion, the workshop helped our members understand and formulate their Child Protection Policies, which represented a crucial step towards ensuring the safety and wellbeing of children within our organization. We established clear guidelines, raised awareness and built capacity to create a culture of child protection that is embedded in all aspects of our work.

Pilot Volunteer Program - Australian Volunteer International.

This one-day workshop aims to explore and provide participants with a deeper understanding of the strengths and needs of volunteers. The SUNGO AVI volunteer delivered the organisational support structures to propel more engagement from volunteers now and in the future and underlying factors and principles of volunteerism.





The participants hear from AVI volunteer representative who volunteer in Samoa and a local volunteer from Piu Community who shared their experiences of current volunteers, mainly the success and challenges of their work.

With this Australian Volunteers Program Impact fund, this project offered to CSOs / NGOs to improve the inductions and capacity building of volunteers across Samoa and beyond.

The volunteer organisations were Samoa Voyaging Society, Samoa Conservation Society, Light of Hope, Samoa Education Network, Apelu Sports, Komiti o Atinae Vailoa Faleata, and Independent Water Scheme Association.

Secured training contracts:

SUNGO received two training contracts this year through the European Union under sub-contract with IDEA and the Government of Samoa through Ministry of Women Community and Social Development (MWCSD). These contracts were aimed at training Civil Society Organisations (CSOs) on Project Design Management, Managing Organisations and other various short online sessions and villagebased sessions on specific areas of development, as well as the strengthening of Good Governance for District Development Programme particularly for 51 District Councils.

These contracts aimed to be implemented in two years period. The detail information about the IOE SAMOA project is under Project update of this report.

In January 2024, SUNGO signed a contract with MWCSD for \$200,000 for Year 1 delivery of Good Governance training to the 51 District Councils with the full 'Agnes to be completed by the end of 2025. Councils will be paired for the training where practicable to reduce the total number of trainings required and to reduce costs.

The purpose of the course is to improve the good governance skills of Councils and to improve their knowledge in areas such as Council Governance practice, staff appraisal, planning, finances, reporting and project management. The training materials are designed by John Cretney with the support of SUNGO CEO and staff. The training of trainers was conducted by John and the training coordinator. Prior to rollout, it was resolved to run a pilot programme with Faleata II district council to fully test the course material and make any further adjustments. The pilot training was carried out on 27 - 30 May with Faleata II Council held at SUNGO conference room.

Given relatively short notice, there was an excellent response from the Faleata II district council with 9 members completing the course and gaining a certificate. A number were unable to fully complete the course due to a village funeral.

Overall, 93% of the responses rated the course as Good (4) or Excellent (5) on a 5-point scale. All questions asked received a rating of at least 80% on average with very high ratings (100%) for the opportunity to participate, level of language used, trainers' skills, relevance of the course and course organization.

Overall, this pilot course ran well and provided useful information for future improvements.

3.4 SQA recognition secured for community courses.

SUNGO planned to complete all documentation for SQA recognition of its new developed training materials such as Good Governance for District Councils and other approved short training courses. The preparation of these documents has commenced and will be completed over the next 12 months. Each course submission is likely to require up to 40 hours of work. When all documents are ready will be submitted to SQA for their recognition usual process.

3.5 Best practice encouraged through mentoring and training

SUNGO provides a range of support to members organisations; training follow up, assistance with financial systems, assistance to complete forms such as applications for donor funding, Government forms for registration, and SUNGO's own membership registration forms. Members find completing funding applications forms very difficult as the language and terminology is often complex.

Individual mentoring and training are preferred and valued by members. However, it requires significant resource in terms of staffing and time availability. SUNGO has only two staff members with the skills to undertake this work. SUNGO staff are the first line for assistance through mentoring but often community trainers provide this assistance under the leadership of the Programme Team Leader.

Strategic Objective Four: Advocacy

The Facility Aiding Locally Led Engagement (FALE) – CSO Forum

SUNGO hosts the Facility Aiding Locally-led Engagement (FALE) Pasifika Co-Creation Meeting, supported by the Pacific Islands Association for NGOs (PIANGO).

The forum delivers a Co-Creation meeting for the Samoan Civil Society Organizations, with the aim to gather humanitarian actors in Samoa to collaboratively envision and create FALE Samoa on 3 - 4 August 2023 at Tiafau Fale hotel Millenia, Sogi.

By emphasizing inclusivity, collaboration, and design thinking principles, the meeting seeks to foster an effective and locally led humanitarian initiative to address pressing challenges in Samoa. Through joint



efforts and cooperation, FALE Samoa can pave the way for a resilient and empowered Pacific community. On the first day of the meeting, participants supported the idea of establishing a FALE for Samoa, through a collaborative effort with SUNGO.



Samoa is part of the first six cohort of hubs

for the Pacific Islands Association for Non-Governmental Organizations (PIANGO), including Fiji, Tonga, Vanuatu, Solomon Islands and Kiribati. PIANGO in partnership with Start Network and Brot für die Welt hopes to establish twenty-four national FALE Pasifika cohorts.

At the end of the forum/meeting, a Steering Committee was formed, to ensure that the FALE Samoa is sustainable. The steering Committee's first meeting will be held on Monday, 7th of August 2023.



Torch of Peace Initiative:

The torch of peace initiative, spearheaded by the Samoa Victim Group, is a beacon of hope and a call to action against the pervasive issue of violence faced by women and girls.



SUNGO as a dedicated advocate for social justice and gender equality is honored to support this vital initiative. By joining forces with the SVSG, SUNGO reaffirm our commitment to creating a world every woman and girl can thrive without the threat of violence. SUNGO staff took part in carrying the torch and making a significant step forward fostering a safer environment for women and girls in our community.

Civil Society and Youth Engagement

The Civil Society and Youth engagement in the OACPS-EU Partnership Agreement forum was held at Taumeasina resort on 14th November 2023. Her Excellency Jutta Urpilainen emphasized the critical need for a robust mechanism to promote youth engagement in dialogues and discussions addressing cross-cutting issues at the National, Regional and International levels. She also encouraged the

commitment to ensuring that the voices of youth are not only heard but actively shape the discourse on matters of Global Significance. There were approximately 60 participants attended both in-person and online from various civil society organisations.



Key points raised during the discussions included:

Inclusive Decision-Making: Participants underscored the importance of inclusive decisionmaking processes, emphasizing the need for mechanisms that ensure the active involvement of diverse stakeholders. This inclusivity, they argued, is vital for the Agreement's success and its ability to address the unique challenges faced by different groups.

Youth Empowerment: Youth representatives expressed their aspirations for increased opportunities and empowerment within the framework of the Partnership Agreement. They highlighted the importance of creating platforms for youth to actively contribute to policy discussions and implementation strategies. **Community Impact:** Civil society organizations shared insights on the potential impact of the Agreement at the community level. They stressed the need for localized approaches to implementation, considering the unique needs and contexts of different communities.

Resource Allocation: Stakeholders sought clarification on the allocation of resources, expressing interest in understanding how funds would be distributed among different regions and sectors. The

One of the core focuses of SUNGO is to strengthen the civil society sector by ensuring that citizens and our communities contributed to the formulation of public policies so it reflected people's realities. These public policies define our National Development Plans and so it's critical that we learn to understand the National Budget process as well because until we have budget allocation, the implementation of

public policies is not guaranteed. To complete the cycle is tracking the budget allocations that is delivered according to the public financial standards and procedures and it's made an impact on the lives of people that is tracked by the Audit process. This is 'people-centred development' in its simplest form.

SUNGO hosts a CSO Forum on 19th April 2024 at Hotel Millenia Tiafau Fale to bring our members and partners to articulate on how Citizens can be empowered to participate in the Budget process and use the



Citizen Budget Guide as a tool to identify priorities to raise as budget submission to contribute to budget formulations.

The upcoming Commonwealth Head of Government Meeting (CHOGM) will be hosted by the Government of Samoa will be a case in point within the conversation on Public Finance Management and Citizen Budget Guide. On that note and in our commitment to transparency, accountability, and citizen empowerment, SUNGO was happy to meet with civil society members who participated in the CSO Forum on Citizen Budget Guide and CHOGM Preparation for People's Forum. This forum aimed to equip the residents of Samoa with accessible and comprehensible insights into the Nation's Financial landscape while also discussing preparations for the People's Forum ahead of CHOGM. The participants were equipped with presentation and information that increased their awareness and



understanding among citizens regarding Samoa's budgetary processes and obligations. Enhanced citizen capacity to monitor and scrutinize Government budgetary decisions. Strengthened dialogue and collaboration between civil organizations, society Government agencies, and citizens in budget-related matters

Pacific Association of Supreme Audit Institutions - PASAI Women Symposium

These trainings have served as invaluable resources, providing Saena with the tools and insights necessary to overcome obstacles, adapt to evolving industry trends, and seize new opportunities.

Strategic Objective Five: Research

The Samoa Umbrella for Non-Governmental Organizations (SUNGO) faced significant challenges in the fiscal year 2023-2024 for its Research Unit, primarily due to a lack of funding. As a result, no new research projects were initiated or completed during this period. This situation impacted SUNGO's ability to contribute to its broader mission of empowering civil society through evidence-based advocacy and informed decision-making.

Impact of No Funding

Stalled Research Initiatives: The absence of funding led to the suspension of research activities. Potential projects that could have provided valuable insights into various social, economic, and environmental issues in Samoa were not pursued especially in the areas of youth, alcohol abuse, violence, and drugs.

Knowledge Gaps: The lack of new research limited SUNGO's ability to generate fresh data and analysis. This affected the organization's capacity to support its advocacy efforts with up-to-date and relevant evidence, potentially weakening its position in policy dialogues.

SUNGO Projects

Initiative on Empowerment of Civil Society in Democratic Samoa (IOE Samoa Project) funded by EU under International Institute for Democracy and Electoral Assistance (IDEA)

This two-year contract is a human rights-based project as articulated in the EU Strategic Framework on Human Rights and Democracy. International Institute for Democracy and Electoral Assistance (International IDEA), in collaboration with project partners Samoa Umbrella for Non-Governmental Organisations (SUNGO) and Women in Business Development Inc. (WIBDI), proudly launched the Initiative on Empowerment of Civil Society in Democratic Samoa (IOE SAMOA project).

The project launch was held on Thursday 20th June. The Director of IDEA Leena Rikkila Tamang and Adhy Aman, Senior Programme Manager from Canberra highlighted the project's aims to support Samoan civil society in advancing human rights, influencing policy and decision-making processes. In attendance were Dignitaries from various consulates including Australia, United States of America, Japan and China. There were also representatives from Government ministries and CSOs and NGOs.

Following the launch, the first Activity for the project was held with a focus on;

- 1. Human Rights and Civil Liberties Issues
- 2. Understanding Media Freedom and the Effective Use of Media to Promote Civil Society
- 3. Advocacy: Understanding and Influencing Government Policy Processes
- 4. Climate Change

Presentations from representatives of the following organisations provided valuable insight for civil society - JAWS, NOLA, Office of the Electoral Commission, Ministry of Women Community & Social Development and Ministry of Natural Resources and Environment.

The project consists of a number of activities aimed at enhancing democratic participation and accountability in Samoa by empowering Civil Society Organizations (CSOs) and Community-Based Organizations (CBOs) to facilitate the engagement of Samoan citizens with their rights and policymakers. Fostering a culture of inclusivity and active citizenship, the project seeks to establish robust foundations for participatory decision-making processes across various stages of policy development, implementation, monitoring, and accountability. The project intends to contribute to the institutionalization of citizen-state engagement as an integral aspect of the policymaking cycle, thereby fostering a sense of expectation among stakeholders regarding the necessity of consultation.

The project, generously funded by the European Union (EUR 415 000), aims at supporting civil society organisations as actors of development and governance in the Pacific Island Countries. A critical part of this project will see organisations (CSOs) receive financial assistance for projects. SUNGO will provide training and mentoring support to ensure projects are managed and reported accordingly.

Living Lab Decarbonated Energy Production in Samoa Project (Microgrid)

This project aims at creating a living lab that is showcased for decarbonized energy projection in the Region. The target is not only to provide clean energy to communities in remote areas but also to provide secure continuity in energy supply in case of power outages. The living lab serves to reduce the C02 emissions and mitigate the effects of CCI. This is meant to be repeated in the Pacific region.

SUNGO has partnered with the National University of Samoa and University of the South Pacific in assisting with this project. The key role of SUNGO is facilitating community workshops and stakeholder engagement.

The village of Uafato has been selected as a small community for this project to take place. After visits to Uafato and meeting the village council an agreement that a microgrid will be designed, installed, implemented and assessed to supply electrical energy, heat and refrigeration to Uafato. The use of renewable energy systems, energy storage systems and hydrogen energy systems will see the use of decarbonized distributed energy. Using microgrids will allow the production of 'green' electrical energy by using renewable energy sources, working either connected to the main utility grid or in a stand-alone mode, making the energy quality more resilient and avoid service disruptions.

Further consultations with Uafato will be carried out to ensure everyone involved in the project understands what the project provides and how it benefits people of Uafato.
